- 1 POA from shipper should be available - original , signed by notary
- 2 EORI registration of shipper
- 3 Commercial invoice- original
- 4 Packing list - original
- 5 Other certificates, requested by customs office, invoices, purchase orders etc.
- 6 Declaration from the producer
- 7 Customs declaration for import in case the goods has been imported to BG.
